## POTENTIAL HAZARD (DANGER)

- Runoff from fire control may cause pollution.
- Inhalation of material may be harmful.

## PERSONAL PROTECTIVE EQUIPMENT

- Protective goggles or face shield.
- Protective gloves.
- Respiratory safety device that will allow driver to escape.
- Light protective clothing.

## DRIVER INTERVENTION EQUIPMENT

- Chemical protective clothing that is specially recommended by the manufacturer.
- Shovel.

---

## DRIVER FIRST ACTIONS - Only if it can be carried out without personal risk

- Contact emergency services.
- Stay upwind, uphill and/or upstream.
- Stop the engine.
- Avoid contact with spilled material.
- Keep unauthorized personnel away.

## DRIVER SPECIAL/ADDITIONAL ACTIONS - Only if it can be carried out without personal risk

- Do not touch or walk through spilled material.

## DRIVER ACTIONS IN CASE OF FIRE - Only if it can be carried out without personal risk

- Large Fire - Move containers from fire area if you can do it without risk.

## FIRST AID

- Administer oxygen if breathing is difficult.
- Give artificial respiration if victim is not breathing.
- In case of contact with substance, immediately flush skin or eyes with running water for at least 20 minutes.
- Move victim to fresh air.
- Remove and isolate contaminated clothing and shoes.

---

## SPECIAL INFORMATION FOR EMERGENCY SERVICES

- Fire involving Tanks - Cool containers with flooding quantities of water until well after fire is out.
- Fire involving Tanks - ALWAYS stay away from tanks engulfed in fire.
- Small Fire - Dry chemical, CO2, water spray or regular foam.
- Large Fire - Do not scatter spilled material with high pressure water streams.
- Large Fire - Dyke fire-control water for later disposal.
